

## How can you ensure that a company is authorized to sell auto insurance policies?

Purchasing your automobile insurance from the right auto insurance company is very important. Every auto insurance company that enters in to a particular state in the United States is required to exclusively submit forms for certification and license to sell auto insurance policies in the particular state.

The Department of Insurance of each state processes the application and ensures that the company is authorized to sell policies in the state by checking through enough financial background and a good set of management and customer service team to provide the required services. If the auto insurance company has enough funds and a good cadre of team for management the license is granted; otherwise, the license for the company is declined.

It is important that one purchases the automobile insurance from the authorized auto insurance company who is licensed to sell insurance in a particular state:-

- It is important to note that the auto insurance company that is a top performer in some other state might not be given even a basic license to sell policies in a different state
- In order for your auto insurance policy to be valid you need to purchase the policy from the licensed auto insurance company .
- Unless you get the auto insurance policy from the right company your vehicle registration proceedings will be on hold; and, you may not be able to drive legally on the road.
- A good auto insurance company would advise you about the best of plans, and some companies despite being licensed to sell policies to high risk candidates may deny auto insurance policies to bad drivers.

The auto insurance company from whom you are getting the policy can also be unlicensed fraudsters. Checking the authenticity of the company by calling up to the Department of Insurance of the State is very important. If you are going to purchase the auto insurance policy from an unlicensed company it may not be valid and you may suffer surprises in events of a claim.

To ensure that you are signing up with the right company it is important that you verify the authenticity of the auto insurance company by calling up to the toll free number of the Department Of Insurance of the state. This would ensure safety and you can file fraud complaints about such people who are fraud agents and fraud companies, you come across, to help your state take actions against.
